Back in December 2007, GAP Institute published its first analysis, which covered the impact of potential border closures after the declaration of Kosovo's independence. Ten years later, GAP has already published over 120 reports and analysis on public policies, initiated hundreds of discussions on public policies and contributed directly and indirectly to dozens of official documents (strategies, decisions, legal acts, parliamentary discussions).

All these activities were organized to fulfill our mission – filling the gap between the government and the people, between problems and solutions, with the purpose of advancing the Kosovo society. We managed this by advocating for better governance, by monitoring the work of public institutions, and by recommending concrete solutions over public policies.

GAP addresses economic, political and social challenges in the country by mobilizing professionals from different fields. In our first decade, 45 professionals were hired to work full time, dozens of external collaborators and at least 50 paid interns.

The works of GAP Institute has been covered extensively by local and international media. The activities of GAP appeared on media on average 750 times during a year. GAP Institute appeared in well-known international media reports, including The New York Times, The Economist, The Guardian, Financial Times, Der Spiegel, Washington Times, Tages Anzeiger, NZZ, etc.

"...Some of Kosovo's problems are stark. According to Kosovo's Institute for Advanced Studies, imports are running at about €1.3 billion (\$1.9 billion) a year but exports at a microscopic €90m-130m. Every year between 25,000 and 30,000 young people enter the labour market, most of them unskilled. Business taxes are much higher than elsewhere in the region; interest rates are prohibitive. Like the rest of the Balkans, Kosovo has a reputation (now somewhat outdated) of being plagued by organized crime—a symptom of a weak state..."



"I have before me two documents. one by the Institute for Advanced Studies GAP, which based on its study, certainly not by obtaining documents from the government because there is no transparency, but managed to find out that the amount invested between 2007 to 2012, amounts to 55 million euros. At the same time, according to KEK officials, from 1999 to 2011, 180 million euros were invested in the power grid, however this figure could be even higher. So then I wish to ask the minister what is the economic logic behind privatisation of an enterprise, where investments is several times bigger than the 26.3 million euros figure."

"According to a report by GAP Institute, where it assesses the reflection on the budget due to changes to the value added tax, it says there more or less that based on the information from Customs in 2014, the net negative effect by lowering the value added tax from 16% to 8%, on the budget of the Republic of Kosovo will be around 5 million euros, however the positive effect by increasing the 16% to 18% will be over 50 million euros. One can clearly see here that the effect on consumer basket, always according to GAP, predicted to increase in price generally by 1% after these tax changes, therefore the consumer will pay more for their basket compared to what they pay now."




